- Supports high density configurations

Cooling

- Power and cooling are delivered under a 36" raised data center floor
- 3,000 tons of N+1 cooling capacity with roof mounted air cooled chillers

- Dual-action interlocking dry-pipe pre-action system with Nitrogen generator corrosion inhibiting system
